

REGULAR MEETING OF THE MUSCONETCONG SEWERAGE AUTHORITY

Chairman Rattner called the meeting to order at 7:33 PM. Following salute to colors, announcement was made that adequate notice of this meeting had been provided for as defined by the "Open Public Meetings Act".

Chairman Rattner introduced Dr. Najarian, of Najarian Associates who has been the MSA scientific consultant over past years.

Chairman Rattner opened and closed the meeting to the public.

Motion made by Mr. Schwartz, seconded by Mr. Sylvester and the affirmative roll call vote of members present for the commissioners to go into closed session at 7:39 PM:

WHEREAS, Section 8 of the Open Public Meetings Act (N.J.S.A. 10:4-12 (b) (1-9) permits the exclusion of the public from meeting in certain circumstances;

WHEREAS, the Commissioners of the Musconetcong Sewerage Authority are of the opinion that such circumstances exist.

Motion to reopen the meeting to the public was offered by Mr. Hoyt, seconded by Mr. Schwab and the affirmative vote of members present at 8:13 PM.

The meeting minutes of May 23, 2013 were approved on a motion offered by Mr. Hoyt seconded by Mr. Sylvester and the affirmative roll call vote of members present.

Mr. Schwab said he discussed some of the expense items that may need budget transfers with Plant Director, Mr. Schilling. Mr. Schilling will follow-up with the MSA accountant and report back to the commissioners. The commissioners discussed the various budget line items and how the transfers can be accomplished.

The Expenditures/Treasurer's Report was accepted on a motion offered by Mr. Schwab seconded by Mrs. Michetti and the affirmative roll call vote of members present.

Mr. Schilling asked if the commissioners had reviewed his monthly report and if anyone had any questions. Mr. Schwab asked about the meter reading for the Borough of Netcong and if there were any problems with the meter. Mr. Schilling said that he had to contact Verizon to have the meter problem at the meter chamber resolved. Mr. Schilling also said that a lot of the lines on the meter chambers are twenty year old, under ground cables. He is considering what the future is for meter chamber transmission and how the changes could be accomplished. Mr. Schwab asked if Verizon would replace their outdated lines. Mr. Schilling said that Verizon does not work on the copper lines anymore and changes have to be made, such as going wireless. Mr. Hoyt asked about the repairs to the drive chain on the new security gate. Mr. Schilling explained that the turnbuckle and cable had to be repaired and the staff made the repairs.

The Repairs and Maintenance Report was accepted on a motion offered by Mr. Pucilowski, seconded by Mr. Hoyt and the affirmative vote of members present.

Lee Purcell, P.E. reported that LTPA attended a seminar at Monmouth University on May 29th that discussed eligibility for projects for Sandy Relief Funding. Mr. Purcell said that a pre-letter of intent

had to be submitted in order to apply for funding. Fenton Purcell, P.E. explained what information the presentation covered and what types of projects would be considered for funding. He suggested that the MSA should have a rudimentary plan for emergencies and asset management and the plan could be built upon over the years. He explained the program is a public assistance program with FEMA, the State and local government as the three agencies that are involved in the program.

Lee Purcell noted that engineering, legal and scientific data must all be factored in concerning the appeal process and it would be discussed further at next month's meeting.

Fenton Purcell reported that he attended a meeting on the Non-Tidal Raritan River TMDL Study and how it relates to the MSA's NJPDES permit issues regarding phosphorus. Mr. Schilling noted that a TMDL was never performed on the MSA due to lack of funding so there is no base line to affect the MSA's case.

Lee Purcell reported on the Phase 2 Handrail Repair Project, Contract #250. Bids were received on June 25th. The lowest bidder, Carjen Fence Company, withdrew their bid due to an underestimation of the work. Mr. Purcell discussed it with Mr. Dwyer who in-turn talked with a representative of Carjen Fence Company. Mr. Dwyer explained that a withdrawal of the bid was permitted by the recent changes to the Local Contracts Law and he promptly received a formal letter of withdrawal from the contractor. A motion was offered by Mr. Hoyt to accept Carjen Fence Company's withdrawal for their bid submitted for the Handrail Repair Project, Contract #250, seconded by Mrs. Michetti and the affirmative vote of members present. Mr. Purcell recommended awarding the bid for the handrail repairs project to the second lowest bidder, CFM Construction, Inc.

Mr. Purcell also reported on the bids for the Interceptor Sewer Rehabilitation, Contract #245. He said three bids were received and National Water Main Cleaning Company was the lowest bidder. LTPA reviewed and checked all three bids. He recommended awarding the bid to National Water Main Cleaning Company.

Mr. Purcell also reported on the preparation of an application that the MSA will be submitting to Roxbury Township to install fencing around Pump Station #2.

Mr. Purcell also reported that LTPA is preparing contract documents for the removal and replacement of existing trash basket assemblies and slide guide systems for Pump Stations #2 and #3. He noted that the work will be under the bid threshold and they will obtain three quotes for that work.

Mr. Purcell also reported on work needed at Pump Station #1 for the installation of an electrical hoist system. The manual system is failing and the MSA would like to install an electric hoist which would cost approximately \$5,000.00. That cost would not include costs associated with running the electrical supply to the pump station. LTPA is processing the documents.

Mr. Schwab questioned whether or not the work for the three projects would need authorization to proceed and noted that the funds would come out of capital accounts. Chairman Rattner explained how the budget and funds would be available for the projects. Mr. Schwab also discussed the engineering fees and budget expenses for engineering. The commissioners discussed the projects and funding for the projects.

Mr. Purcell also reiterated the importance to have an Asset Management Plan in place.

The Engineer's Report was accepted on a motion offered by Mr. Pucilowski, seconded by Mr. Schwab and the affirmative vote of members present.

Res. No. 13-18 Awarding Contract No. 245 to National Water Main Cleaning Company for Rehabilitation of Interceptors and Appurtenances, was moved by Mr. Hoyt, seconded by Mr. Keiser and the affirmative roll call vote of members present.

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Musconetcong Sewerage Authority that Contract No. 245 be awarded to National Water Main Cleaning Co., on its bid of \$189,400.00; and be it

FURTHER RESOLVED, that the Secretary of the Musconetcong Sewerage Authority is hereby authorized and directed to return the bid bonds of all of the unsuccessful bidders, except for the bid bonds of Tri-State Grouting, which shall be returned upon receipt of a fully executed Contract and all other required documents from National Water Main Cleaning Co.; and be it

FURTHER RESOLVED, that the amount of the Contract shall not exceed \$189,400.00 without further approval from the Musconetcong Sewerage Authority, and the Musconetcong Sewerage Authority shall not be liable to pay any amount over and above \$189,400.00 without prior written approval; and be it

FURTHER RESOLVED, that Steven Rattner as Chairman is hereby authorized to execute the Contract with National Water Main Cleaning Co., on behalf of the Musconetcong Sewerage Authority.

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Musconetcong Sewerage Authority that Contract No. 250 be awarded to CFM Construction, Inc., on its bid of \$149,200.00; and be it

FURTHER RESOLVED, that the Secretary of the Musconetcong Sewerage Authority is hereby authorized and directed to return the bid bond of Carjen Fence Co., Inc., the Secretary shall retain the bid bond of RML Construction, Inc., which shall be returned upon receipt of a fully executed Contract and all other required documents from CFM Construction, Inc.; and be it

FURTHER RESOLVED, that the amount of the Contract shall not exceed \$149,200.00 without further approval from the Musconetcong Sewerage Authority, and the Musconetcong Sewerage Authority shall not be liable to pay any amount over and above \$149,200.00 without prior written approval; and be it


