FURTHER RESOLVED, that the Musconetcong Sewerage Authority publish in the official newspaper of publication a legal advertisement advising of the award as required by N.J.S.A. 40A:11-5.

# **RESOLUTION NO. 17-17**

Resolution of the Musconetcong Sewerage Authority Awarding a Contract to the Parsippany-Troy Hills Township Wastewater Treatment Plant to Treat Sludge On an Emergency Basis

WHEREAS, the Musconetcong Sewerage Authority (hereinafter "MSA") has a need for treatment of liquid wastewater and disposal of sludge at a licensed treatment facility in the event of an emergency for the period from February 28, 2017 through February 1, 2018 pursuant to the provisions of N.J.S.A. 40A:11-5; and

WHEREAS, the anticipated term of this contract is one (1) year; and

WHEREAS, Parsippany-Troy Hills Township Wastewater Treatment Plant has submitted a proposal dated January 17, 2017 indicating that they will accept sludge for emergency purposes only as follows:

- 1. Acceptance of Sludge is for emergency purposes only;
- 2. Sludge is priced at \$0.07/gallon as per ordinance;
- The hours of operation to discharge are 7:00 a.m. to 3:30 p.m., Monday through Friday:
- 4. The approximate amount of gallons is 20,000 per week to 65,250 per week;
- 5. The Authority is required to meet all Federal and State Regulations;
- 6. The Authority's account will be billed for the wastewater.

WHEREAS, N.J.S.A. 40A:11-5(2) permits the award of a contract without public advertising for bids and bidding with a public body of this State of any subdivision thereof; and WHEREAS, Parsippany Troy Hills is a public corporation of the State of New Jersey; and

WHEREAS, MSA believes it is most advantageous to procure a contract for emergency purposes to treat its sludge at the treatment facilities of Parsippany-Troy Hills; and

WHEREAS, the Secretary/Treasurer of the MSA has certified that funds are available in the annual budget of the MSA.

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Musconetcong Sewerage Authority that a Contract is hereby awarded to Parsippany-Troy Hills Township for the emergency treatment of the sludge from the MSA as follows:

- 1. Acceptance of Sludge is for emergency purposes only;
- 2. Sludge shall be priced at \$0.07/gallon as per ordinance;
- The hours of operation to discharge are 7:00 a.m. to 3:30 p.m., Monday through Friday;
- 4. The approximate amount of gallons is 20,000 per week to 65,250 per week;
- 5. The Authority is required to meet all Federal and State Regulations;
- 6. The Authority's account will be billed for the wastewater.

BE IT FURTHER RESOLVED, that Steven Rattner as Chairman of the MSA is hereby authorized to sign an Agreement between Parsippany-Troy Hills and the MSA; and

BE IT FÜRTHER RESOLVED, that the MSA publish in its official newspaper a legal advertisement advising of the award as required by N.J.S.A. 40A:11-5.
