The monthly correspondence was discussed. One of the commissioners asked about the monthly collection system report received from Mount Olive Township. Mr. Schilling said that the MSA receives a report every month, but it is not put on the correspondence. Chairman Rattner said that it was interesting to see and asked why the other towns do now submit reports. Mr. Schilling said the towns should be submitting monthly reports and he would like to see monthly reports submitted from each of the member towns, although the MSA has no authority over how the towns manage their systems, but if there were any issues in their collection systems or pump stations it would be good to know. The commissioners further discussed what should be required from the member towns and that the MSA should be notified for any work completed, or issues that arise, that specifically include the Authority's system and property.

Mr. Schilling asked if the commissioners all had a chance to review his monthly report and if anyone had any questions. Mr. Schilling updated the commissioners on the sludge disposal for the month of February.

Mr. Schilling also asked about the Quick Check proposed and asked Chairman Rattner about the allocation for the project. Mr. Schilling reported that he had forwarded the letter to the commissioners via e-mail because the engineering firm that submitted the letter referenced a few projects. These projects could potentially be impacting many of the seven member towns and the MSA may want more visibility as to how these projects may affect each of the towns. Currently, the project engineer is talking about property in Byram Township and the proposed Quick Check will be between Byram and Stanhope. He said he corresponded with the project engineer who said there are also projects under consideration in Roxbury, Mount Olive and Netcong. Mr. Kron suggested that the Quick Check project engineer should be instructed that they need to contact each of the individual towns involved for the property allocations. Mr. Schilling said he forwarded the information to the commissioners so that each of them would be aware of what is being planned in their municipalities. The commissioners further discussed the available

allocations for each of the towns. Mr. Kron said that he would forward to the commissioners a letter he had prepared some time ago regarding the sale of gallonage for the member towns.

The Repairs and Maintenance Report was accepted on a motion offered by Mr. Schwab, seconded by Mr. Benson and the affirmative vote of members present.

Lee Purcell, P.E. reported there is still no new progress on the request for appeal process/stay.

Lee Purcell, P.E. also discussed that NJDEP Asset Management Program and suggested that the MSA start drafting a plan. He mentioned that having the Asset Management Program in place would be beneficial when applying for funding through the New Jersey Environmental Infrastructure Program. The commissioners discussed starting an Asset Management Program and what would be included. Mr. Purcell also recommended that LTPA and Mr. Schilling meet with Alan Dillon of the NJDEP Asset Management Program.

Mr. Purcell also reported on the water service for Pump Station No. 6 and is still recommending that the MSA award the contract for the work to Tom Valiante and Son, Inc.

Mr. Purcell also reported that the winter work for the emergency handrail repairs has been completed. He said there is more work to be completed that is weather dependent and the contractor will come back to finish the work when the weather permits.

Mr. Keiser asked Mr. Purcell about the proposal he submitted to finish the handrail design work for the remainder of the repairs. Mr. Purcell reported that he had submitted a proposal for the completion of the handrail repairs to the commissioners, which was attached to his report for the meeting. The commissioners discussed Mr. Purcell's proposal and the work that would need to be completed. Mr. Purcell explained the time lines for the project from the design process, to bidding and completing the work. He recommended starting the project as soon as possible so that the work can be done in the warmer weather. Mr. Keiser suggested that the Operations, Maintenance and Safety Committee should meet and go over the proposal. Mr. Schwab suggested that the commissioners approve the design and bid period work for LTPA to start and hold off on the construction period. Motion offered by Mr. Benson, seconded by Mr. Keiser to authorize a contract with LTPA for the handrail repair engineering fees for the design period in the amount of \$15,000.00 and the bid period in the amount of \$2,000.00 for a total of \$17,000.00. Mr. Purcell also reported on the proposal he submitted for the repairs to the MSA interceptor that have been discussed previously. LTPA was not able to include the work required as a change order on the contractor's contract because of the legal impediments. LTPA's proposal for the project would be a total of \$34,000.00. He explained the importance of the work to the MSA system and not completing the work needed would cause the system to deteriorate in time. Mr. Pucilowski suggested that the Operations, Maintenance and Safety Committee should review it and get back to the commissioners at the next meeting. Mr. Purcell also offered to meet with the committee to discuss the work needed.

The Engineer's Report was accepted on a motion offered by Mr. Bates, seconded by Mr. Benson and the affirmative vote of members present.

Mr. Schwab suggested that the Finance/Audit Committee meet with the TD Bank Trustee representative. The commissioners discussed the various other banks that could be appointed as MSA trustee bank.

RESOLUTION NO. 13-09

Resolution of the Musconetcong Sewerage Authority Authorizing US Bank, N.A., to Invest the Monies in the Bond Reserve Fund Account in Treasury Notes or Treasury Bills to Yield the Maximum Rate of Return

WHEREAS, on December 20, 2012, the Commissioners of the Musconetcong Sewerage Authority adopted Resolution No. 12-45 which included a Corrective Action Plan to contact area banks for investment options and rates; and

WHEREAS, it is in the best interest of the MSA to invest the monies in the Bond Reserve Fund Account Number 2576021761 totaling \$1,538,475.00 in Treasury Notes or Treasury Bills to yield the maximum rate of return, and that these funds should be invested, but be made available on December 31, 2013 to be used to make the Final Debt Service Payment on the 2002 Refunding Bonds on January 1, 2014.

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Musconetcong Sewerage Authority that Steven Rattner as Chairman is directed to authorize US Bank, N.A., to invest the monies in Bond Reserve Fund Account No. 2576021761 totaling \$1,538,475.00 in Treasury Notes or Treasury Bills to yield the maximum rate of return, but that these funds must be available on December 31, 2013 to be used to make the Final Debt Service Payment on the 2013 Refunding Bonds on January 1, 2014.

Mr. Keiser said that the acceptance of the alternate engineer was to be discussed and the Plant Director had a recommendation for the alternate engineer. Mr. Schilling reported that since the commissioners discussed the matter at the last meeting, the committee had interviewed two of the engineering firms after receiving proposals from six firms. He reiterated that they had recommended CP Engineers at the last meeting and that he is still recommending that the Authority appoint CP Engineers as the alternate engineer for the MSA. Mr. Kron suggested that the information should be sent to him and he would prepare a resolution for approval at the next meeting.

Mr. Benson reported he and Mr. Schilling met with some potential new risk management consultants, since there was a lack of satisfaction with the risk management consultant the MSA had appointed over the last several years. He recommended Stanford Risk Management Services and indicated they were a lot more comprehensive than the MSA's former consultant. Mr. Benson further explained some of the other services that would be provided by Stanford Risk Management. The commissioners decided to appoint Stanford Risk Management as the MSA risk management consultant. Mr. Kron would prepare a resolution for approval at the next meeting.

Motion made by Mr. Pucilowski, seconded by Mr. Sylvester and the affirmative roll call vote of members present for the commissioners to go into closed session to discuss personnel matters at 9:07 PM:

WHEREAS, Section 8 of the Open Public Meetings Act (N.J.S.A. 10:4-12 (b)
