Mr. Pucilowski asked about the correspondence received regarding the NJDEP Compliance Inspection on June 27th. Mr. Schilling explained that the EPA conducted an unscheduled inspection. An enforcement agent from the NJDEP was also present. Subsequently, a report was issued indicating that the DEP Agent had also conducted an inspection of the facilities that date and everything was in compliance. The following correspondence for the month of July was received and filed on a motion offered by Mr. Sylvester, seconded by Mr. Schindelar and the affirmative vote of members present.

Mr. Schilling asked if the commissioners had reviewed his monthly report and if anyone had any questions. Chairman Rattner said that the revised Capital Program Report looked good. Chairman Rattner and Mr. Schilling thanked Mrs. Michetti for her help revising the report. Chairman Rattner updated the commissioners regarding the Capital Program and also talked about the current MSA debt service. The Engineering Committee will decide what projects are currently needed and the Finance Committee will meet to discuss budgeting and costs for the projects.

Mr. Schilling reported that the Engineering Committee held a meeting on July 11th to discuss the currently needed capital projects. He followed up with a summary of that meeting, which he sent to all the commissioners. He noted that there are a series of resolutions on the agenda for some of the projects currently needed. The Engineering Committee's recommendation was to proceed in 2019 with the headworks project and 2020 for tertiary treatment. Mr. Schilling also noted that he put recommendations in his monthly report for the resolutions that are on the agenda, along with costs for the projects.

Mr. Schilling updated the commissioners that he passed the UST exam for a Class A-B Operator UST License. He had forwarded a copy of the certificate to the commissioners.

Mr. Schilling also reported that Hopatcong, Netcong and Roxbury had new meters installed in their meter chambers earlier that day. All of the six meter chambers that the MSA owns and manages have now been upgraded.

Mr. Schilling summarized the number of call-ins due to rag blockages and power failures for the month of July.

The Director's Report for the month of July was accepted on a motion offered by Mr. Pucilowski, seconded by Mr. Schindelar and the affirmative vote of members present.

The Repairs and Maintenance Report for the month of July was accepted on a motion offered by Mr. Schwab, seconded by Mr. Schindelar and the affirmative vote of members present.

Mr. Wancho updated the commissioners regarding Contract #270. The drive units are scheduled to be shipped on August 15th. The sandblasting and painting covered under Change Order #1 has been completed. They are waiting for the final pieces of equipment to finish the work inside the tank. PS&S was able to obtain two quotes for additional rehabilitation work that may be necessary for Sludge Thickener #3. GMH submitted the lowest quote.

Mr, Wancho reported regarding the primary clarifier drive replacement work. GMH started the painting and sandblasting of Primary Clarifier #1. The drive unit is scheduled for delivery on July 31st. Primary Clarifier #2 is scheduled for shipment on August 13th.

Mr. Wancho also reported that PS&S has been working on the effluent micro strainers. They have looked at a new micro strainer unit, which is Huber. They also made a site visit to Hightstown Wastewater Treatment Plant to look at the Leopold filters. PS&S is comparing costs and reviewing which equipment would be best for the MSA Plant.

The Engineer's Report for the month of July was accepted on a motion offered by Mr. Schindelar, seconded by Mr. Bruno and the affirmative vote of members present.

Resolution No. 18-33 - 2017 Annual Audit Certification was tabled until the August 23rd meeting. Chairman Rattner noted that the Finance Committee has met to discuss the 2017 Audit, but they still need to meet with the Auditor.

Chairman Rattner suggested that Resolutions #18-35 through #18-41 be considered for approval with one consent resolution vote. He noted that they were all related to the same work that was previously discussed. He asked if any of the commissions would like to discuss any of the individual resolutions or had any objections. There were no objections. A motion was made by Mr. Schindelar to approve Resolution #18-35, Resolution #18-36, Resolution #18-37, Resolution #18-38, Resolution #18-39, Resolution #18-40 and Resolution #18-41, seconded by Mr. Schwab and the affirmative roll call vote of members present.

WHEREAS, the Musconetcong Sewerage Authority is desirous of engaging PS&S to perform said work; and

WHEREAS MSA desires to utilize the contract obtained by PVSC with GMH; and WHEREAS GMH has provided a Quote (Quote #Q18158T) for such services to MSA dated July 12, 2018 pursuant to PVSC Contract B108-10 in the amount of \$17,300.00; and

WHEREAS MSA has ordered the DBS S25-AE Drive Unit and delivery is expected in the near future; and

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Musconetcong Sewerage Authority that the Director is hereby authorized to award a contract to GMH for installation of a DBS S25-AE Bridge Mounted Drive Unit; and
